Before submitting this form, carefully read the following important information.

When to use this form:

- Transfer a current Pennie-certified Broker to a different Pennie Agency (i.e., a different company).
- Transfer active customers from one Pennie Agency to another Pennie Agency (this may occur at the same time as a Broker is being transferred to a different Pennie Agency).

When not to use this form:

- Adding new Brokers to an existing Pennie Agency (this can be processed by Agency Manager).
- Removing a Broker from an existing Pennie Agency (this must be processed by Broker Customer Service).
- Changing a current Broker into an Agency Manager role (this must be processed by Broker Customer Service).
- Changing an active customer designation from one Broker to another Broker within the same Agency (this can be processed by Agency Manager).
- Accepting a new customer designation request.
- Terminating a customer designation.
- Creating a new Agency on Pennie.
- Change to your insurer contracts, appointments, or method of payment of commissions. Whether you work directly with the insurer, or with other organizations like General Agencies (GAs), these changes should be processed directly with your insurer and are outside of the scope of your Pennie Agency portal.

New Pennie Agency	The Agency to which the Broker and/or customers will be transferring	
Broker	Pennie-certified Broker	
Agency Manager	A special role for some Brokers within an Agency that allows them to create new Brokers within their Agency and move customers to other Brokers within their Agency	

If the Broker being transferred is an Agency Manager: The Current Pennie Agency must have one or more Agency Manager users other than the Broker that is being transferred. If the Broker that is being transferred is the only Agency Manager on the Current Pennie Agency, the Broker must give the Agency Manager role to one of the other Brokers within the Current Pennie Agency. This action must occur prior to submitting this form.

If there will be zero Brokers left in the Current Pennie Agency, Pennie will decertify the Current Pennie Agency upon completion of this request.

If the Broker being transferred with current designated Pennie customers is starting a new independent Agency: A New Pennie Agency account must be created prior to submitting this form. Follow these instructions to create a New Pennie Agency.

Signoffs: This form requires signoff of the Current Pennie Agency, the New Pennie Agency, and the Broker being transferred.
